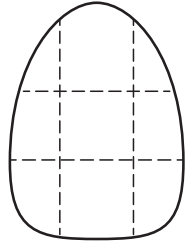

Gnathodontics performs work based only upon a prescription from a dentist and thus is responding to a personal request for services (and not to the P.C.). Therefore, it is our understanding that when a doctor requests work from us that he or she is personally guaranteeing that payment will be made for services rendered.

Payment for laboratory work is due 30 days after the invoice date. A service charge of 1.5% per month will be charged on past due accounts. Accounts with balances over 60 days will automatically be placed on COD. To receive a 3% DISCOUNT, your payment must be received in this office by the 10th.

All accounts over 120 days delinquent will be placed with a collection service (if arrangements are not made with Gnathodontics for payment). The cost for collection service, attorney fees, court costs, and other expenses incurred in collecting past due balances or insufficient fund checks will be added to the amount owed by the doctor, as permitted by law. Gnathodontics is obligated to report delinquent accounts to our credit bureau.
